  - Staff attended the Quarterly State Water subcontractors meeting.

  - Staff continued to be busy with adjusting the system to chloramines. We are using 100% State Water and will begin mixing the wells back in.
- Capital Projects
  - Staff is getting costs for the installation of a back-up generator at the office as part of our SCADA system
  - SMS temporary contract signed
